The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth and that such probable cause is based on the following facts:

On 1/1/2020, Officers of the Myrtle Beach Police Department responded to Derriere's located at 804 Seaboard Street, which is located within the city limits of Myrtle Beach, SC for a shooting. Officers discovered once on scene that no person(s) from the establishment had called the Police Department. The actual call came in from an on duty Myrtle Beach Police Officer, who learned from Broadway at the Beach Security that there was a shooting at Derriere's. Myrtle Beach Police Officer Davis contacted dispatch to inquire if a call for shots fired had been reported. There was no call for a shots fired at Derriere's. Officers were dispatched to the location upon arriving on scene it was learned that shots were fired and there was a victim on scene. The crime scene had signs of being cleaned. It was learned through the investigation that an employee of Oz Night Club was on the phone with an employee of Derriere's and she stated that shots had been fired. The defendant was on scene during the incident and listed on her statement form she submitted to Myrtle Beach Police, that she is an owner of the business. Based upon the above facts, there is probable cause to believe the defendant did fail to report an emergency after observing a nuisance posing an emergency threat to the public health or safety or to immediately report the incident to the Myrtle Beach Police Department, a violation of City Ordinance Section 10-24.
